

Separation


For couples who separate but don't divorce, a separation deed can help them formalise their separation and deal with certain legal issues.

There are many reasons why a premarital agreement may be a good idea:

1	To predict the outcome of any divorce settlement before you marry.
2	To save on costs and acrimony that sometimes result in divorce proceedings.
3	To prevent speculative claims following a short marriage.
4	To protect family assets which are intended to pass through generations.
5	To protect those marrying later in life or for a second time, who may not have children.
6	To limit the claims of a second spouse, and so protect the needs of children from

previous marriages.


When parental alienation happens, it is essential not just to address the parents' behaviour, but also to consider the child's best interests.
